## **Officer Reports:**

President Anthony Guzzo

- Stated that the DVFA has hired the firm of Seitz Consulting, LLC in reference to *Financial Assistance in Establishing Methodology for the Calculation of Per Run Costs Related to Ambulance Runs for Basic Life Support. He will be meeting with this group tomorrow*
- Stated that we have received a proposal from VFIS regarding the task force recommendation to evaluate the office operation from top to bottom. The total cost is \$6,750.00 to do this study. After much discussion, it was decided to pass this info along to the task force committee for their review.
- Stated that he feels that we should give Pablo Reyes a \$500.00 gift card for his services with the new office computer/server work that he has done at no charge for the past several months. *Motion by Steven Maichle and seconded by Joe Zeroles to accept the President's recommendation and present Pablo with a \$500.00 gift card. Motion carried*
- Stated that he would like to look at appointing a Sunshine committee. He will research this idea and talk with Blake Bowers, Charlie Arnold and Rev. Wilms to get their input on this.
- Stated that there has been several Officers meetings in the past few months regarding the office operation. Melissa Kiser has resigned her position with the DVFA. She did receive a severance package. Warren Jones will continue as he has done in the past and the Officers will monitor his duties and responsibilities.
