# **Report of Officers**

#### **President Betts:** (copied and pasted from written report)

With the support of a fine group of Officers, I have been enjoying a year that seems to be on a very fast track, although being very rewarding.

Jay and Dan have stepped in for me whenever they were needed, and Jay has been a big help at Legislative Hall assisting Warren. They have doggedly contacted the 15 new Legislators and have spent many hours tracking both the good and the bad legislation. We have also completed a guide for the DVFA Directors to follow and assist the table officers with their many obligations. Terry and Ray continue their efforts on making the Treasury Reports transparent, and easy to understand through a new tracking system they implemented. Budgets have

been completed for the Conference that Ray is handling, and the general operating expenses led by Terry. Finally, Elmer continues to perform quietly and efficiently as Secretary and the go-to guy for the Conference.

This quarter contained some large events and started out with the FDIC Conference in Indianapolis, IN. The attendance at the event is now over 35,000 people and I had the pleasure of meeting and discussing Fire Service issues with some of the top personnel in the United States. Provident invited our delegation out to dinner on Wednesday night, and we also attended their open house on Friday night.

I attended the CFSI Dinner in Washington, DC, and had the privilege of sitting at the head table. I also paid for my wife to attend, and she was available to take pictures of me presenting the Delaware check for \$49,800.00 to Bill Webb. 166 members of the Delaware Fire Service and Ladies Auxiliaries attended the dinner, with a lot of coaxing from Bill Tobin and Ron Marvel. I also received a check of \$6,000.00 from Provident for our partners in progress, and another \$1,000.00 from them to the Foundation for scholarships.

I attended the Eastern Division Conference in Hightstown, NJ on May 10<sup>th</sup> and 11<sup>th</sup> with my wife, and there were some great speakers there on building construction and leadership. The conference showcased speakers from the New Jersey Fire Service. I attended on my own finances, and there was a good showing from Delaware including Bill and Carol Walton, Jon and Peggy Townley, Terry and Joie Jester, Les and Sandy Warrick, and Jim and Debbie Watson.

The majority of the Executive Committee met on a Conference Call to discuss the priorities of the DVFA for the extra monies projected by the Delaware DEFAC Committee. Warren sent these requests to Finance Director Mike Jackson on May 8<sup>th</sup>. The Conference Call worked well, and I think that we need to have them more frequently for better communications within the Executive Committee.

On May 21<sup>st</sup> & 22<sup>nd</sup>, I attended the National Benefits Summit in Minneapolis, MN. Each state was available to make a short presentation, and I did one on the Delaware Fire Service. I believe that there were 18 states represented. It was very informative with a lot of discussion on Cancer Presumption, Recruitment and Retention, and Pension plans. I took four pages of notes, but I have not had a chance to formally update them. I decided to go on my Presidential stipend to check this out. They have been meeting since 1999, and Harrison Breuer of FASNY got my name from a list at the New York Fire Chief's Conference in Turning Stone when I was going through the Eastern Fire Chiefs. I also saw Jerry DeLuca of New York and spent a lot of time discussing the Fire Service together. Jerry worked for the New York State Chief's as Executive Director and he is currently working for FASNY. Bob Timko and Danielle Weber from Provident were also there. I will get my report posted on the website in the near future.

Please be prepared to step up and help us out with any legislation that needs to be pushed through for the benefit of the Delaware Fire Service during the rest of the June session.

Finally, once again, I would like to thank all the invitations to my wife and me to all the banquets since the first of December. I am sorry to have missed some due to more than one invitation on the same night but filled in with some of the other officers. I have especially enjoyed the companies that I had not had the chance to visit before this year. Every event was special, and we were treated like royalty.

#### First Vice President Jones: (copied and pasted from written report)

For the 3<sup>rd</sup> quarter of 2019, I have been quite busy attending 42 events, over 123 hours of service and traveling 5,872 miles.

I had the opportunity to attend the FDIC Conference in Indianapolis, Indiana and CFSI Conference in Washington, DC. Both events had wonderful seminars and classes that I was able to attend.

The bulk of my time and travel this quarter has been to Legislative Hall in Dover. I have been working on trying to secure funding and find additional funding for the fire service. I have also been working with the legislature on bills such as Cancer Presumption Legislation, which will be covering not only Cancer, but PTSD and cardiac issues as well. We also look forward to a resolution being put forth by the House of Representatives and the Senate for a Task Force for recruitment and retention of the volunteer fire service.

I've also been in close contact with the State EMS Association in their endeavors to lobby for the current optional drug list for BLS ambulances to be moved to a mandatory list. Which would ensure a standardize care statewide to the citizens of our state. A lot of work has been put into this. Especially with the information of how Safe Harbor affects us.

I'm still working with the State of Maryland Fire Service. It looks like there has been great progress for them joining the BLS states compact in 2020, and to my understanding the state of Pennsylvania as well.

I've lined up wonderful seminars for this year's conference in September. Along with our normal Pension and Financial Seminars. We are adding topics with a panel discussion on combination fire departments. A seminar on equality versus equity and PTSD. Along with hearing from our State Auditor. I'm still working to line up seminars for Cancer in the fire service and an Active Shooter class. I look forward to a wonderful conference this year.

Lastly, the 2020 Officers and I will be assigning committees in August. I encourage everyone to sign up to work on a committee this year. We, as a whole, make up this great association. We are only as strong as our working members. I need your help and input to make this association stronger and take us to a new level. When it comes down to where the rubber meets the road, we are neighbors helping neighbors, just ordinary people doing extraordinary things to meet our community's needs.

I met with Scott Crawford on May 23rd. We now have access to monitor our account.

Ray and I have been looking into some type of device/service so Warren can take credit card payments from the vendors for the conference. Right now we have narrowed it down to either Eventbrite or PayPal.

# **Executive Manager Jones: (copied and pasted from written report)**

Legislative Items: There are 10 legislative days left.

**HB117:** This is the house bill I send out and made some additional copies which I put out this morning. We have been asked to present an opinion on this legislation. The sponsors are Rep. Kowalko and Senator Ennis. It has to do with prohibiting harmful flame retardants in children's products, upholstered furniture and mattresses that have been known to cause cancer. For years the fire service has advocated flame retardants in these kind of products. However, I do not see how we can be against a bill that protects children from cancer.

**SB126:** This is our presumption legislation. It was filed May 31st and is assigned to the financial committee in the Senate. It is listed on their committee list. We are hoping it is on their agenda on June 12.

**Recruitment and Retention Task Force Resolution:** It is scheduled to be voted on in the house this Wednesday, June 12 at 2:00 pm. We are asking for anyone who is available to come to legislative hall for the vote on this resolution. It would be nice to have a good showing. During the Governor's Inaugural speech he said we can't kick this can down the road anymore. He was talking about budget deficits. Well this is another can that can't be kicked down that road also. Anyone who is planning to come on Wednesday, let me know I'll try to arrange seating in the chamber. Also, plan to be there a while. We are trying to get it voted on in both chambers. If you want to and have a uniform, wear it. If not, wear your pocket badge on you suit coat something that identifies you as fire service.

**SB39:** Is a 15 page bill that was in my mailbox in Leg Hall on Tuesday. The act permits a court before imposing a fine.....to consider the defendant's ability to pay and it gives the court the discretion to waive the fines. We

were concerned about how this would affect our fine money. So, Jay and I worked this bill last week. Collectively and separately we spoke to the Prime Sponsors Senator Brown and Senator Townsend. We also talked to Senator Ennis about the bill and he was going to get his attorney to look into it. Some people are telling us it is dead or arrival, meaning it won't pass. Some are telling us it won't affect us. We will work it this week and if we need phone calls made we will send out an email.

**Safe Harbor:** As reported before we are still working on the Safe Harbor Issue. So far all Hospitals with the exception of Christiana and Beebe have responded back. Most are in agreement with one on one exchanges. There is some differences. Once we here from all the hospitals we will put together a list and send it out.

**Other items**: Jay and I met with the Secretary of Human Services, the Director of the State Benefits Office and Deb Lawhead as well as the President of the Funeral Directors Association and the Past President. The meeting was about some questions that have risen over reasonable funeral charges for volunteer company members. There was a healthy discussion on the issue and it was decided we would put our thoughts together and meet again in July.

I met with the chair of the Bond Bill Committee and have communicated to the Budget Director on our request for additional money. While neither would confirm anything, both were optimistic about our request. We will be attending the Bond Bill Committee Meetings on June 19 and 20.

As we find more about all the things we have reported on we will keep you informed. I'd like to take the opportunity to wish us all a great June 30<sup>th</sup> and a Happy 4<sup>th</sup> of July.

#### Advisory to State Fire Marshal – Grover Ingle (copied and pasted from written report)

- Fire Fatalities Currently, there are eight (8) fire fatalities for 2019. Of those eight (8) fire fatalities three (3) had working smoke alarms and five (5) did not have working smoke alarms. Two (2) with the working smoke alarms had other circumstances that prevented the victim from getting out of the structure and one (1) the victim was out of the structure however went back in for her pet. All of these incidents still remain under investigation, four (4) are accidental, three (3) are criminal and one is undetermined currently. Three (3) occurred in New Castle County, one (1) in Kent County and Four (4) in Sussex County.
- Deputy Fire Marshal III John Galaska and K9 Tanya will be attending recertification training from July 8 -12, 2019 in Maine.
- Sussex County Investigation Staffing We are down two personnel on the Investigative side in Sussex. Deputies from Kent and New Castle have been assigned to assist with the shortage of staff when needed.
- Office Manager Christine Galaska has been promoted to the Office Manager position in Kent County effective April 1, 2019.

- Administrative Specialist I Lora Crowley has been hired for the Administrative Specialist I position in Kent County. Lora began employment with the Office of the State Fire Marshal on May 28, 2019.
- Division of Forensic Science The Division of Forensic Science has begun testing fire debris for our office. They received accreditation for this service and have two certified Laboratory Technicians to perform the testing.
- Sprinkler Save Rehoboth Beach (NFSA Weekly Highlights Attached) Rehoboth Beach Fire Company responded to a townhouse fire in the 300 block of Peeble Way on May 25, 2019 around 3:00 PM. On arrival they found a fire in the dryer unit that had vented outside of the dryer which was contained by a sprinkler head. Minimal damage and the residents were able to reoccupy the townhouse. Good job by the DE sprinkler coalition.

## TUESDAY, SEPT, 10<sup>TH</sup> (9-11 AM AT CONFERENCE):

### ANNUAL PENSION SEMINAR:

Dave Craik, Pension Administrator for State of Delaware will be joining us to <u>DISCUSS OUR</u> <u>PENSION PLAN AND A POSSIBLE CHANGE FOR US TO CONSIDER GOING FORWARD.</u>

### ISSUES TO BE DISCUSSED ARE:

- <u>YES</u>, we can infuse \$1M into our present plan, Yes, however it would only raise our funding level from 58% to approx. 63%.
- THE DVFA/LADVFA LOSAP is currently <u>underfunded by \$14.5 million \$</u>

## <u>REFERENCE = CURRENT PLAN:</u>

This represents a <u>"Rolling 15 Year Plan"</u>. This is how it was established back in 1986. Every year the unfunded liability is amortized over a 15 year period and the "employer's share" is adjusted annually. According to Dave, under this Plan, it will <u>NEVER GET To 100% FUNDED</u> if all actuarial assumptions are met.

#### REFERENCE = A NEW PLAN

This is a second option. It is called the "Closed Amortization Plan".

The yearly Volunteer Fire Contributions, REMAIN AT

\$450 ANNUALLY rather than decreasing annually. With this Plan, our LOSAP Plan gets to 84% funded by 2028 and will become fully funded by year 2033.

- Remain with the Current "15 Year Rolling Plan", OR
- Request by Letter, that we wish to change to the "Closed Method". (Dave would present it to the Pension Board Members for their approval).

# **OLD BUSINESS**

By-Law change to Article II: Section 2 (C) **DUTIES OF THE OFFICERS** The change would be adding the following sentence at the end of the duties of the Second Vice President. "IN THE EVENT OF DEATH, RESIGNATION OR INABILITY OF THE SECOND VICE PRESIDENT TO PERFORM HIS OR HER DUTIES, THE COUNTY ASSOCIATION FROM WHERE THE SECOND VICE PRESIDENT WAS INITIALLY NOMINATED SHALL HOLD AN ELECTION AT THEIR NEXT REGULARLY SCHEDULED MEETING TO NOMINATE A MEMBER IN GOOD STANDING TO COMPLETE THE REMAINING TERM OF THE SECOND VICE PRESIDENT. THE NOMINATION SHALL BE CONSIDERED AND ELECTED AT THE NEXT SCHEDULED OR SPECIAL EXECUTIVE MEETING BY MAJORITY VOTE"

Motion by Joe Zeroles and second by Ernie Layfield to accept the by-law change as presented. **Motion carried** by a unanimous voice vote

## **NEW BUSINESS**

- Motion by Ed Barlow and second by Mark Gott to support HB 117 (Flame Retardant Materials) Motion carried
- Marvin Sharp discussed the travel budget and the number of DVFA Officers that are allowed to travel to various functions. He referenced to a motion that was made on September 16, 2016 that only allowed for 3 DVFA Officers to travel to any one event at the DVFA expense. A motion was made by Marvin Sharp and second by Ernie Layfield to overturn the previous motion and the new motion would be "Any DVFA Officer wishing to attend an event on the DVFA's behalf, may do so with the consent of the DVFA President within budgetary reasons" This motion will supersede the 3 DVFA Officer travel rule. Voice vote was too close to call, so President Betts requested a roll call vote keeping in mind that it takes a 2/3 vote to overturn the original motion. Roll call vote was 82 yea and 8 nay Motion passed
- Jason Capps, President of the DSEMSA talked about the new medication list that needs to be added as mandatory items for all ambulances. *Motion by Jason Capps and second by Ernie Layfield that a letter be sent to the Fire Commission recommending that these new medications be added to the mandatory list for all ambulances.* Much discussion took place regarding cost, availability, expiration dates, re-stocking, etc. *A motion was made by Bernie Nutter and second by Russell Hooper to table the motion. Motion carried*
- Eric Haley and Jack Wilson discussed in great detail, the future of the volunteer fire service. There are 3 distinct counties in the State, with 3 distinct different staffing needs. Vice President Jones stated that there is a seminar at Conference that will address these issues. Try to attend this seminar, bring your thoughts and concerns.
- Question was raised regarding smoke detectors. As you heard from the Fire Marshal, we have already had 8 fire deaths this year, most of which had no working smoke alarm. The DVFA is looking for grants, State money and even Corporate funds to purchase smoke detectors.

Since Ken McMahon was back in the room, President Betts invited him to the podium and bestowed the honor of him being inducted as the newest President Emeritus of the DVFA. A formal presentation will be made at the Conference.
