# **Executive Manager Jay Jones:** (copied from written report)

It has been a privilege to represent the Delaware Volunteer Firefighters Association (DVFA) throughout the state and at various out-of-state events. I commend the leadership for their exceptional commitment and achievements within the organization. Please find the updated legislative report for 2025 attached.

As we look to the future, I am eager to collaborate closely with the incoming officers and support their initiatives. One important recommendation is for the organization to review and update its mission and vision statements. As the fire service landscape evolves, it is crucial that our mission and vision reflect these changes to ensure our ongoing success.

To achieve this, we should engage in long-range planning that envisions our desired position and reputation over the next two decades. This approach will help us establish clear benchmarks, strategies, and tactics to measure our progress toward our vision. While we handle numerous daily operational tasks, a focused and clear vision is essential for maintaining relevance and avoiding obsolescence in these changing times.

Additionally, I recommend that we explore partnerships with reputation management firms to enhance our public and corporate advocacy efforts. These alliances can also assist us in identifying and managing grant opportunities. By forging strategic relationships with industries and companies that align with our mission, we can secure financial support that enables us to reduce membership dues while continuing to provide high-quality programs and maintaining standard operational procedures.

It Is crucial to acknowledge that achieving these objectives will require the expertise of professionals in these areas, as the scope of work exceeds what our volunteers can manage alone.

The DVFA office remains steadfast in its commitment to supporting fire departments. Please do not hesitate to reach out for assistance.

Following the **conclusion of the first leg of the 152**<sup>nd</sup> **General Assembly, the final report** is presented. Please note that any legislation not fully processed by June 30<sup>th</sup> will be deferred until the second leg of the session, scheduled to reconvene in 2026.

HB 230, The Grant-in-Aid Bill. Signed by Governor 7/1/25

One time 50k for each company: 3,200,000 this comes to 50,000 pre company

Each company in FY25 received 36,000, up in FY26: 37,500.

Per ambulance in FY25 received 15,000, up in FY26: 20,000 per ambulance

Rescue trucks one time per company: FY25 6,030, up in FY26: 8,000.

Ladder truck one per company: FY25 15,000, up in FY26: 16,000.

Per boat in FY26: 3,722, up in FY26: 4,000.

Per substation: 25,000, up in FY26: 30,000.

Leveling up for Kent and Sussex: FY25 39,951, up in FY26: 42,000

Equalization for Kent and Sussex in FY25: 95,000, up in FY26: 101,650.

Just in Grant in Aid, the Fire Service received a total of \$16,458,013.

# SB 200, The Bond Bill signed by Governor 7/1/25

Rescue Tools Replacement. It is the intent of the General Assembly that the funds authorized in the Section 1 Addendum of this Act be used to reimburse the Delaware State Fire School and Belvedere, Christiana, Farmington, Five Points, Frankford, Goodwill, Greenwood, Gumboro, Laurel, Leipsic, Little Creek, Magnolia, Marydel, Newark, Port Penn, Roxana, Slaughter Beach (Memorial), and Wilmington Manor fire companies. Upon submitting the receipt of sale, each company will be reimbursed up to \$7,500 by the Fire Prevention Commission, State Fire School for a total of \$142,500.

State Fire Marshal's Office Residual Funds. The Office of Management and Budget, Division of Facilities Management is authorized to utilize any remaining funds from Fire Marshal's Office Building Improvements for the State Fire School's Structural Buildings Repairs/Reconstruction project.

Funding for a Pole Barn for the Fire School New Castle Division 750,000.

Community transportation funds; Five Points Fire Company \$10,000 for command vehicle equipment, Holloway Terrace \$95,000 chiefs command vehicle, Leipsic Fire Company \$45,000 command truck, Townsend Fire Company \$30,000 brush truck American Legion Department \$45,000 command vehicle.

# HB 226, One Time Supplemental Appropriation signed by Governor 7/1/25

This Act provides an appropriation of \$400,000 to Department of Safety and Homeland Security, State Police, Executive and \$400,000 to Fire Prevention Commission, State Fire Prevention Commission for First Responder – Wellness Application Support. The expenditure of these funds is intended to deliver support and resources to first responders through the implementation of a wellness application for use by law enforcement officers and firefighters through fire companies statewide.

## HB 225, The State Budget for FY 26 signed by Governor 7/1/25

The FY26 Fire Prevention Commission budget includes \$75,000 for fire prevention education reimbursement to fire companies. \$52,000 is also allocated to the state chiefs association for fire training. The total budgets for the Fire Commission, Fire School, and Fire Marshal's office out of the general fund is \$9,164,400.

SB 4 Establishes an independent and nonpartisan Office of the Inspector General (OIG) signed by Governor 8/14/25

ACT TO AMEND TITLE 29 OF THE DELAWARE CODE RELATING TO THE OFFICE OF INSPECTOR GENERAL.

SS1 for SB21 Townsend, signed by Governor 3/25/25

AN ACT TO AMEND TITLE 8 OF THE DELAWARE CODE RELATING TO THE GENERAL CORPORATION LAW.

SB28-SA1 Brown, signed by Governor 9/9/25

AN ACT TO AMEND TITLE 18 OF THE DELAWARE CODE RELATING TO FUNERAL EXPENSES FOR CERTAIN VOLUNTEERS WITH FIRE OR AMBULANCE COMPANIES. Changes wording in the code.

SB 29-SA1 Brown, assigned to Finance Committee.

An Act to amend Title 18 of the Delaware Code relating to funeral expenses for certain volunteers with fire or ambulance companies; increases benefit from \$7,000 to \$10,000.

**SB 46,** Mantzovinos, passed the Senate and awaits a House floor vote. An act to amend Title 21 of the Delaware Code relating to autonomous vehicles.

HB 82-HA1, Carson, assigned to Appropriation Committee.

An act to amend Title 18 and Title 29 of the Delaware Code relating to death benefits; changes wording and increases benefits (\$7,000-\$8,000).

HB 63, Wilson-Anton, ready list for the House floor vote

AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO FIREWORKS.

HB 124, Williams, signed by Governor 9/9/25

AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO STATE FIRE MARSHAL FEES.

HB 133, Snyder-Hall, awaiting House vote.

AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE RELATING TO FINES, FEES, RESTITUTION, AND OTHER COURT-RELATED MONETARY OBLIGATIONS.

HA 2 Clarifies that toll, red-light, and speed-camera violations are not eligible for hardship waivers or modifications.

SB 158, Pinkney, assigned to the Senate Judiciary Committee, pulled for Committee

AN ACT TO AMEND TITLE 10 OF THE DELAWARE CODE RELATING TO COMMISSIONERS OF THE DELAWARE STATE FIRE COMMISSION (CISM).

HB 139, Bush signed by Governor 7/30/25

AN ACT TO AMEND TITLE 18 OF THE DELAWARE CODE RELATING TO LINE-OF-DUTY DEATH HEARINGS

This would eliminate unnecessary LODD hearings.

**HB 199,** Wilson-Anton, Motion to Release Failed in House Economic Development/Banking/Insurance & Commerce Committee.

An act to amend Title 18 of the Delaware Code relating to distributions to fire companies and departments. Met with the sponsor and she will hold the bill until January to give us time to poll the member companies.

HB 202, Wilson-Anton, passed House Committee waiting House floor vote

AN ACT TO AMEND TITLE 21 REGARDING CIVIL PENALTIES FOR SPEEDING, adding a \$10 assessment to other traffic violations.

HB 171, Heffernan, signed by Governor 9/9/25

AN ACT TO AMEND TITLE 14 OF THE DELAWARE CODE RELATING TO ELECTIVE CREDIT FOR VOLUNTEERING WITH LOCAL FIRE DEPARTMENTS.

We are keeping an eye out for potential legislation that may be drafted by trial lawyers. This legislation, which could involve insurance and cost the fire service a lot of additional money if we serve alcohol within our hall rentals, has been seen in other states and was very costly. We are staying vigilant and on top of the matter should a bill ever come to fruition.

We are still working on a draft bill for federal background checks. This draft is the third from the Joint Sunset Committee. The DVFA challenged all three drafts and requested to be part of the process. (certification for firefighters, make the

Commission Investigators law enforcement powers, and Background Checks) We will work on a background check bill this summer to be ready for January.

We are approaching legislators to draft a bill allowing fire police to have red flashing lights, in addition to their blue flashing lights, on the rear of their light bars to comply with state law. We are waiting on a support letter from the Police Chief's Council to move forward.

We will be working on a draft piece of legislation to allow fire chiefs to authorize and revoke members responding to the firehouse using blue and white lights when responding to alarms.

President DiCristofaro, Chief Mike Edwards, and I had a productive meeting with the Governor.

We continue to ask the state to fund the Delaware State Fire School to teach all classes listed in 709, as they are now unfunded mandates, and we see some fire departments sending students to other states where it is cheaper. This would help all fire departments' budgets.

We intend to schedule meetings with the Fire Caucus and the Governor after conference to review the 2026 priorities.

#### **FEDERAL**

OHSA updates are on hold to allow the volunteer and union firefighters to provide additional input before moving forward. Eric Haley, Aaron Moore, and I have served on red ribbon panels during this process. We have had many meetings and it is in the hands of Department of Labor and OHSA to bring back a response to our reports following the Red Ribbon panels

SAFER and AFG grants are being paid out again.

The National Fire Academy was reopen and be running again. Delaware weekend is scheduled.

The National Cancer Registry is also back up and running. Delaware has poor numbers; we need to get our members, active and retired, to get on the registry. Everyone needs to sign up on the registry Delaware numbers are very low

President DiCristofaro, Jeff Brown, and I met with Senator Coons and his staff to discuss AFG and SAFER grant programs that need more funding, setting customer standards for lithium-ion batteries, federal tax credits, and the Honoring Our Fallen Heroes Act.
